Request for one (1) year extension of Minor Subdivision approval

MLUL: N/A

Pursuant to N.J.S.A. 40:55D-47, the approval of a minor subdivision shall expire 190 days from the date on which the resolution of municipal approval is adopted. The resolution was adopted on November 1, 2017 and 190 days is May 10, 2018. The statute allows the board to grant an extension not to exceed one year from what would otherwise be the expiration date or May 10, 2019. Accordingly, the applicant requests a one (1) year extension to May 10, 2019.

#### b) PB 17-10 WINDSOR OAKS

Preliminary/Final Major Subdivision 1203 Windsor Road; Block 34 Lot 4 Property Zoned: RR/C District

MLUL: 5-16-18

The applicant is seeking preliminary and final subdivision approval for a residential subdivision straddling the border of West Windsor and Robbinsville Townships. Three (3) proposed lots are located in West Windsor, consisting of two residential building lots and an open space lot. The proposed building lots in West Windsor are conforming, but if the Board requests that an additional portion of the property in West Windsor be dedicated as open space the applicant shall seek relief for an undersized lot and any other relief resulting from the dedication. Technical relief for the size and depth of the open space lot proposed to be dedicated to the Township may also be required. The proposed right of way will straddle the municipal boundaries.
