- 1. On the division line of Proposed Lot 15.02 and Lot 4, Block 28, South 45 degrees 15 minutes 00 seconds East, a distance of 18.01 feet to a point and continuing the following (3) courses over and through Proposed Lot 15.02, Block 28; thence
- 2. South 11 degrees 10 minutes 00 seconds West, a distance of 151.90 feet to a point; thence
- 3. South 64 degrees 01 minutes 53 seconds West, a distance of 565.70 feet to a point; thence
- 4. South 44 degrees 46 minutes 01 seconds West, a distance of 477.44 feet to a point on the common line with Proposed Lot 15.02 and Lot 15.03; thence
- 5. On said common line, North 42 degrees 08 minutes 07 seconds West, a distance of 15.02 feet to a point and common corner with Proposed Lot 15.02, Block 28, Proposed Lot 15.03, Block 28 and Lot 3, Block 28; thence
- 6. On the common line with Lot 3 and Lot Proposed 15.02, North 44 degrees 46 minutes 01 seconds East, a distance of 479.17 feet to a point; thence
- 7. On said common line, North 64 degrees 01 minutes 53 seconds East, a distance of 560.79 feet to a point; thence
- 8. On said common line, North 11 degrees 10 minutes 00 seconds East, a distance of 154.40 feet to the point and place of **BEGINNING**.
