Floor and Décor Outlets of America, Inc. seeks minor site plan approval to occupy 76,283 sf of the 1-story building (former Wal-Mart) for use as a Floor & Décor hard surface flooring store. The building is part of a condominium, which including common elements encompasses 63 acres for the center as a whole. Applicant proposes to add a new loading dock, make improvements to the parking lot, and install customary signage. Applicant seeks variances for temporary signage, and design standard exceptions relating to loading spaces and the size of building signage. Parking is proposed to increase by three spaces from 5,543 to 5,546.
