Section 1: Designation:

Effective upon installation of signage and traffic paint, the designated space at the norther corner of the front parking lot of the West Windsor Police Department, which is located at 20 Municipal Dr, Princeton Junction, NJ 08550, be officially open and available to the public as a "Safe Exchange Zone" for conducting in-person transactions that have been facilitated through online marketplaces. There shall be no schedule regarding the use of this area as intended.

The Township of West Windsor makes no guarantees, assurances, or promises as to the safety or security of any in-person transactions that may take place on Township property; the Township of West Windsor also makes no guarantees, assurances, or promises to the condition or authenticity of any items exchanged between private parties at the "Safe Exchange Zone". The Township is not offering or incurring any liability, stated or inferred, related to the exchanges that may occur at this location.


Section 4: Safe Practices Encouraged:

Township officials encourage all residents to engage in such transactions in daylight hours, only; to bring a cell phone along in case of an emergency; to notify friends and/or family of the intention to meet to conduct such a transaction; to never invite strangers to the home or agree to meet at a stranger's home; and to reconsider any transaction with someone who refuses to meet at the "Safety Exchange Zone," located at the Police Station.

AND BE IT FURTHER RESOLVED, that the Mid-Jersey Joint Insurance Fund has reviewed and approved the standards for the "Safety Exchange Zone".
