WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A: 65-1 et. Seq., ("Act") provides that any local governmental unit may enter into a contract with any other local governmental unit to provide or receive any service that each local unit is empowered to provide or receive within its own jurisdiction; and

WHEREAS, mutual aid and assistance agreements between municipalities, counties, law enforcement agencies, police, emergency medical service, fire departments, fire companies or EMS organizations and fire departments situated in fire districts operated by a Board of Fire Commissioners, are permitted, pursuant to N.J.S.A. 40A: 14-26 and 40A: 14-156.1; and

WHEREAS, the President in Homeland Security Directive (HSPD-5), directed the Secretary of the Department of Homeland Security to develop and administer a National Incident Management System ("NIMS"), which would provide a consistent nationwide approach to Federal, State, local and tribal governments to work together more effectively and efficiently to prevent, prepare for, respond to and recover from domestic incidents, regardless of cause, size or complexity; and

WHEREAS, "The New Jersey Civilian Defense and Disaster Control Act" App.A9-33 et. seq., provides for the health, safety, and welfare of the people of the State of New Jersey during any emergency by centralizing control of all civilian activities having to do with such emergency giving the Governor control over the resources of each and every political subdivision to cope with any condition that shall arise out of such emergency; and,

WHEREAS, the Director of the Division of Fire Safety in the Department of Community Affairs promulgated rules in accordance with the "Fire Service Resource Emergency Deployment Act," N.J.A.C. 52:14E-11 et. seq., commonly referred to as the "Fire Service Resource Emergency Deployment Regulations" N.J.A.C. 5:75A et. seq.; and WHEREAS, the Governing Body of the Township of West Windsor deems it to be in the best interest of the Township of West Windsor to enter into a Mutual Aid and Assistance Agreement with participating units throughout Mercer County and all of their departments, authorities, boards, commissions and other functions under the auspice of each participating unit including but not limited to, law enforcement, public works, emergency medical services, fire departments, emergency management, human services, hazardous materials response units, technical or special operations teams, Community Emergency Response Team ("CERT") members, Medical Reserve Corps ("MRC") members or other volunteers and other jurisdictions defined as "local governments" in the Homeland Security Act of 2002; and

WHEREAS, N.J.S.A 40A:14-26 and 156.1 et seq. authorizes interjurisdictional mutual aid; and

WHEREAS, the Governing Body of The Township of West Windsor and the Participating Units recognize the benefit of entering into an agreement for mutual aid and assistance with each other to protect against loss, damage or destruction by fire, civil unrest, hazardous material, major criminal or emergency events, natural and man-made disaster or catastrophe and to address those situations when additional aid and assistance is needed to protect the best interest of the persons and property of each individual jurisdiction.

- WHEREAS, the Plainsboro Volunteer Fire Company #1 is willing to transfer ownership of this trailer to the Township of West Windsor for police use with the understanding and acknowledgement that the trailer has not been inspected and certified by the Plainsboro Volunteer Fire Company #1; and,
- WHEREAS, the Township of West Windsor acknowledges their responsibility and liability for licensing, operation and certification of the trailer; and,
- WHEREAS, the Township of West Windsor agrees to assume responsibility, defend, hold harmless and indemnify the Plainsboro Volunteer Fire Company #1 from any and all liability for any personal injuries, property damage and/or damage to other vehicles caused by or related to the transfer of ownership of this trailer to the Township of West Windsor for the use, possession and control of said trailer.
- NOW THEREFORE, BE IT RESOLVED that the Township Council of the Township of West Windsor shall accept the donation of the trailer "AS IS" Condition; and
- BE IT FURTHER RESOLVED that the Township Council does hereby authorize the Mayor and Township Clerk to execute Memorandum of Understanding and all documents necessary to effectuate the donation from the Plainsboro Volunteer Fire Company #1.

ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF WEST WINDSOR ESTABLISHING PROCEDURE FOR THIRD PARTY HIRING OF POLICE OFFICERS AND AMENDING CHAPTER 82 "FEES" SECTION 82-18 POLICE OF THE TOWNSHIP CODE

WHEREAS, the Township of West Windsor permits its police officers to engage in offduty special police work ("extra work"), as is provided for in the "Agreement Between the Township of West Windsor, the West Windsor Police Superior Officers Association (SOA) and West Windsor PBA Local 271 A/K/A New Jersey State Policeman's Benevolent Association Local 271 West Windsor" ("PBA Agreement"); and

WHEREAS, the Mayor and Township Council of the Township of West Windsor desire to implement and codify a procedure for the hiring of its police officers to engage in extra work to ensure fairness and efficiency.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF WEST WINDSOR, THAT:

Section 82-18 Police of the Code of the Township shall be amended as follows:

§H. Police Officer Extra Work

1. Pursuant to the Superior Officers Association (SOA) Agreement and the PBA Local 271 Agreement, police officers are permitted to engage in "extra work," which is defined as "services in the nature of special or private police duty provided by employees in their offduty hours to individuals, groups, clubs institutions and others who make payment for such services, and which services the Township is not expected or obligated to provide as a normal police function (e.g. traffic duty, security at private parties or events, club or school dances, football games, etc.)."

2. No employee shall be required or compelled to work extra work.

3. All requests by prospective employers shall be submitted through the Office of the Chief of Police, or his designee, within the Police Department. The Township may engage a third-party intermediary to schedule extra work assignments for police officers.

4. The hourly cost shall consist of a special hourly rate agreed upon by the Township and the recognized collective bargaining units to be paid to officers working extra work assignments, plus a reasonable administrative fee, which covers the administrative cost, overhead and out-of-pocket expenses to the Township for providing the service, including any fees owed to third-party contractors.

5. All other details concerning extra work shall be as set forth in the operative Superior Officers Association (SOA) Agreement and the PBA Local 271 Agreement.

Section 2. Repealer. All ordinances or parts thereof inconsistent herewith are repealed as to such inconsistencies.

Section 3. Severability. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section 4. The ordinance shall take effect upon its passage and publication.
