#### PUBLIC COMMENT

Mr. Warren Mitlak, 5 Stonelea Dr., Noted he would like the Health Department to post the Annual Report to the website prior to the meeting and also advised the copy on the Township's website is not up to date.

Council President Mandel thanked Ms. Swanson for the comprehensive report and noted it was very easy to read.

Ms. Swanson responded the process is the Board of Health Annual Report will be posted to the Township Website after review by the Board of Health which is being done at this meeting.

Ms. Swanson also took some time to review important topics in the report.

- Funding for Health Education and outreach programs will be ending this year therefore there will be a decline in education and programs for the public
- Overview of Goals and Objectives for 2025
- Open to feedback and suggestions for future Annual or Quarterly reports

Ms. Swanson also noted there are two Resolutions on the Business Session Meeting to include appointing Jean Ward as the new Registrar and a renewal of shared services with Robbinsville Township.

Council Member Geevers stated her concern whether the new Shared Services Agreement would cover increased costs to the Township.

Ms. Swanson replied a more in-depth cost analysis could be conducted in the future. She also stated in the past some of these towns have taken over the shared programs and reallocated those responsibilities back to their townships to keep the hours and costs contained.

Ms. Swanson gave an update on respiratory illnesses from the state and urged residents if they have not gotten their influenza vaccines this would be a good time to do so. She also gave an update on Avion Influenza and the recommendations and precautions for the general public to follow. Many links have been posted to the Health Department's page for more information. If the public notices deceased birds they are requested to call the NJDEP and the local Police Departments non-emergency number. Ms. Swanson does not recommend homeowners dispose of deceased birds. She also addressed Council President's concerns about back yard bird feeders and said there is no known risk but to always take caution when feeding birds and cleaning the feeders.

Ms. Swanson gave an overview of the Lead Safe Housing Statistics and compliance issues as well as the Township's Dog Licensing statistics overview. She noted the ways the Health Department is working to notify and educate the public on voluntary compliance. A discussion ensued with Council President Mandel, Councilmember Gawas, Council Vice President Geevers and Ms. Swanson about education and
